Annual General meeting

The AGM was held on 8 August at the FIA Hall. The President of the Fiji Indian Association, Mr. Salim Ashwin Singh, welcomed everyone and thanked them for their attendance, and their ongoing interest in the welfare of the Association.

A hard copy of both the Secretary's and Financial Reports were available at the meeting.

Amendments to FIA's Constitution

As agreed at the last AGM (2009), the Constitution was revised and a number of amendments were incorporated into a final draft. This was presented at the AGM by Prabodh Mishra, Chair of the Review Committee. A number of suggestions from the floor have been incorporated in the draft amendments, and the final amended Constitution will be sent in due course to the FIA members who were at the AGM. The revised Constitution will be filed with the Charities Commission.

Former President's Activity Report

Mr. Salim Ashwin Singh gave an overview of the activities undertaken by the FIA in 2009-2010 financial year. The highlights included:

- Girmit Diwas function attended by some 250 people. For the second year in a row, the function was organised with the help of sponsors at no cost to FIA.
- A successful dinner night, with excellent profit largely due to the high level of sponsorship the Association managed to attract.
- A kirtan night last October attracted a number of mandalis.
- The installation of a heat pump in our Hall at Halford Place, Petone was made possible with a \$2,000 grant from the Hutt Mana Charitable Trust with assistance from Trust Chairman, Mr. John Burke and Trust Member, John Terris. The total cost of the project was \$3,600, and the balance came from the FIA's own resources.
- The use of the FIA Hall by members of the community for various functions including poojas, social gatherings, cultural and linguistic activities, and funeral services.

Mr. Salim Ashwin Singh thanked his Committee members for their hard work and for their diligence and commitment. He also thanked FIA's Board of Trustees for the role it has played.

In his inaugural speech, the President Elect Mr. Vinod Kumar, acknowledged the hard work and dedication of the past President and his Committee. He commented that Mr. Singh has given his unflinching support to various organisations associated with our Association, and his untiring efforts for the enhancement of our Association. This was deeply appreciated by one and all.

First Meeting of the New Committee

Mr. Vinod Kumar outlined his **vision** during his term of Office at the first meeting on 19 August 2010. This is replicated here in full.

Immediate

- 1. Membership Drive the fall in membership number from over 250 previous year to 177 last year is of concern. We need a vigorous campaign to increase the number.
- 2. Access to web site to be restricted to Communication's Advisor, the President and Secretary.

3. Opening hall facilities for members for social pool, table tennis, and kava on Sundays from 3pm to 7pm. This will bring in some money for running the hall expenses.

Short Term

- 1. Monthly updates of the Business Plan
- 2. Organise some form of reward for membership.
- 3. Assisting other charitable organizations by raising funds ...kirtan, bhajan , qawali nites.
- 4. To be seen in the community have a blood donation day.

Medium Term

- 1. Events for members like Dinner Nite
- 2. Children's functions...Summer carnival
- 3. Functions for the elderly Provide transport to and from the FIA Hall.

Long Term

- 1. Reassessment of property and lease requirements.
- 2. Discounts on bulk purchases for our members for wedding, birthdays and funeral expenses.
- 3. FIA's involvement with other Fiji Communities in Wellington we need to broaden our outlook

These are Mr. Kumar's personal objectives upon taking the Presidency. He added that some of these will overlap and will be incorporated in the FIA's Business Plan

Other Items:
